Maternity Worldwide is an international non-governmental organisation (INGO) saving lives in childbirth in low-income countries. Our vision is of a world in which all women and their babies can access safe and appropriate childbirth regardless of where they live.

The charity was started in 2002 and has grown both in income and diversity of programmes. We have worked in 11 low-income countries and currently have three integrated maternal health programmes in Malawi, Uganda and Ethiopia with ambitious plans to expand our work over the next 4 years so it is an exciting time to join the organisation.

We currently have three members of paid staff (one full-time and two part-time based in our office in Brighton) and a network of dedicated, active volunteers and Trustees.
