Job title: Trustee - Lead for Programmatic Work in Uganda

Job purpose: To provide strategic oversight of the programmatic and research

work of Maternity Worldwide in Uganda and Chair the Uganda

Programme and Research Group

Hours: Approximately eight hours a month

Maternity Worldwide exists to help reduce the number of women dying or injured in childbirth. We are the UK's leading charity dedicated to saving lives in childbirth overseas.

Maternity Worldwide is an international non-governmental organisation (INGO) currently with two members of paid staff (in the UK) and a network of volunteers. The organisation was started in 2002 and has grown both in income and diversity of programmes. Maternity Worldwide has recently embarked on exciting plans for our Uganda programme. In partnership with Help Hoima we have commenced a two year integrated maternal health project that seeks to enhance access to quality maternal healthcare in Hoima, north-west Uganda.

To help us expand further and consolidate our integrated maternal health project in Uganda, we are looking for an enthusiastic Trustee with knowledge and experience in International Development and or Maternal and Newborn Health to be the Maternity Worldwide Board lead for Uganda and Chair the Uganda Programme and Research Group which reports to the Board.

The Trustee will work closely with the Grant Funding and Programme Support Manager. The Uganda Programme and Research Group meetings are currently held in London. The Trustee will also be expected to attend the Maternity Worldwide Board meetings. Board meetings take place quarterly: two are held mid-week in London in the evening and two are held on a Saturday in Brighton.
